Project Descriptions

Anchorage Senior Activity Center Renovations Phase II - \$350,000

The Anchorage Senior Activity Center (ASAC) is a facility that serves thousands of seniors for health and wellness, fitness and social activities. ASAC serves as a central community facility for numerous organizations and agencies that need meeting space, events, and partnership activities. This funding will provide facility upgrades and safety improvements to a 37-year old building, including but not limited to: install ADA guards and handrails; replace air compressor; repair/replace windows; install wayfinding interior signage and directory listing activities, times, and locations; complete safety and security upgrades of garage.

Chugiak-Eagle River Senior Center Phase II - \$300,000

This phase will provide needed facility enhancements with specific improvements to include engineering assessment of septic system; landscape upgrades; heating, ventilation, and air conditioning (HVAC) upgrades; apartment renovations; and other safety/code upgrades at Chugiak-Eagle River Senior Center (CERSC). CERSC is a 100,000 sq. ft. facility built in 1975 that provides 42 independent, 20 affordable housing units, and 20 assisted living units plus 100-250 meals per day as well as over a dozen other programs for the Center and the community.

Loussac Library – Alaska Room - \$500,000

This funding will be used for the creation of a new Alaska Room at the Loussac Library. The project includes building a new Alaska Room and restoring the adjacent meeting areas of the Ann Stevens Room and Galleria, which are used for author talks, book discussions, community dialog, and art exhibits. The COVID-19 pandemic has highlighted the importance of libraries sharing information and creating connections during uncertain times. This project can be a path forward in our community's recovery, providing a place where community members of all ages and backgrounds can come together to learn, share and develop solutions to today's issues. If passed, these funds will help secure a \$390,000 federal challenge grant and will be matched by \$700,000 in private donations.
